(54) Title: NOVEL PLAKOGLOBIN INTERACTING PROTEINS

(57) Abstract: The present invention relates to novel proteins interacting with human plakoglobin. More particularly, the present invention relates to novel proteins that are involved in transduction of a plakoglobin related signal to the nucleus.
