(54) Title: IDENTIFICATION OF NEUROBLASTOMA TUMOR SUPPRESSOR GENES

(57) Abstract: The present invention relates to a new tumor suppressor gene family. More specifically the present invention relates to a tumor suppressor involved in suppression of neuroblastoma. Said tumor suppressor is involved in the generation of micronuclei and in the removal of acentric chromosomal fragments that might contain amplified DNA.
