(54) Title: RECOMBINANT OLIGOMERIC PROTEIN COMPLEXES WITH ENHANCED IMMUNOGENIC POTENTIAL

(57) Abstract: The present invention relates to a chimeric protein comprising an antigen and an oligomerisation domain. The present invention relates further to recombinant oligomeric protein complexes comprising said chimeric protein and the use thereof for the manufacture of a vaccine.
