(54) Title: USAGE OF ZINC FOR PREVENTING TNF-INDUCED PATHOLOGY DURING CANCER THERAPY

(57) Abstract: The present invention is based on the finding that treatment with zinc, in addition to tumour necrosis factor (TNF) and/or interferon-gamma (IFN- $\gamma$ ), results in significant tumour destruction and complete protection against TNF-induced lethal-shock. The present invention thus relates to the usage of zinc to prevent and/or treat pathology, and more specifically to prevent or treat TNF-induced pathology.
